Abstract

The article examines the prospects and significance of the development of military tourism on the territory of Ukraine after the end of the Russian-Ukrainian war, which in the future can become one of the important directions of patriotic education of the young generation of Ukrainians and highlighting the scale of the events of the war in the world. The influence of wars and conflicts always negatively affects the tourism sphere, however, the objects that remain after such events can serve the development of such a direction of tourism as military tourism, attracting the attention of both domestic and international tourists. Title of the paper MULTI-CRITERIA INTEGER LINEAR FRACTIONAL OPTIMIZATION

FROM APPLIED PERSPECTIVES

Abstract In the paper we propose a method for solving the linear-fractional

multicriteria optimization model with identical denominators in whole numbers. It should be noted that such models are in arowing demand, especially from a practical application point of view. The procedure for solving these types of models initially involves assigning utilities (weights) to each criterion [15], at the discretion of the decision-maker, after which a single-criteria fractional linear optimization model is built, which is a synthetic function of all criteria weighted. It was found that the optimal solution of the weighted model does not depend on whether the optimal values of the criteria used in the objective function are of real or integer type. This finding is very important because the decision maker has the possibility to combinatorially select the type of objective function values involved in the synthesis function. By changing the utility values, the decision maker can determine a new optimal compromise solution of the original model. The theoretical justification of the algorithm is presented in the paper. The algorithm was tested on several examples, which proved its effectiveness.

BIBLIOMETRIC ANALYSIS OF SCIENTIFIC TRENDS IN THE

VEGETABLE SECTOR

Abstract

The bibliometric analysis undertaken in this paper is considered to be important to understand and perceive the key topics related to the vegetable sector. At the same time, the current state of scientific research in this sector is presented with the aim of providing useful reference points to young researchers, as well as updated information for the academic environment. 3,008 scientific works published between 1974 and 2022 were analyzed, most of them being included in the following categories: food science technology, 442; environmental sciences, 384; horticulture, 327; agronomy, 265; multidisciplinary agriculture, 236; green sustainable science technology, 234; agricultural economics policy, 231; energy fuels, 231; economics, 203; plant sciences, 190. Scientific papers were extracted from the Web of Science Core Collection and the links between them were mapped using VosViewer software. The results obtained complement the previous research regarding the knowledge of scientific trends for the vegetable sector and the expansion of future research directions for the studied field.

MATILA C. GHYKA: DE LA NUMĂR LA ARMONIE ȘI PROPORȚIE

DIVINĂ

MATILA C. GHYKA: FROM NUMBER TO HARMONY AND DIVINE

PROPORTION

Abstract

Matila C. Ghyka has become famous in 1931, when he published his masterwork "The Golden Number" ("Numărul de aur", in Romanian), which had a significant influence on the international plan. His first major idea was dedicated to outlining the mathematical symmetry in the esthetical theory. For the author, the concept of symmetry in the understanding of physical interactions was proven to be extremely fertile in physics, in the way in which the central idea of the Quantum Theory of the fields is exactly the one of a symmetry that generates interactions between the fields and their quantum. The intuition of Matila Ghyka, of a relation between science and art, based on the concept of symmetry with "the golden number" does not result from occult acceptations; actually, the definition of "the golden number" is formulated in extremely simple mathematical terms: a segment of a straight line is divided in two new segments, a and b, so the ratio between the length of the total segment and the length of segment a is equal to the ratio between the length of the a segment and the length of the b segment. Subsequently, the author shows that the golden number establishes an organic connection between the human being and the dynamics of the pulsation of life in the vegetable world, and the world of marine organisms, is found in the architecture - from the Egyptian and Greek temples to the cathedrals of the Middle Age, and also in correspondence with the proportions of the human body. The second great intuition of Matila Ghyka is linked to the necessity to formulate a mathematical theory on the rhythm. From the number, through rhythm, the divine proportions are reached, which are found everywhere in the Universe.

In summary, these principles can be formulated as follows: phasing out non-recoverable waste and reducing pollution, keeping products and materials at the highest value of use for as long as possible, and regeneration of natural systems (biodiversity and ecosystem).

ACCESIBILITATEA ECONOMICĂ A POPULAȚIEI REPUBLICII MOLDOVA LA SERVICIILE LOCATIV-COMUNALE ECONOMIC ACCESSIBILITY OF THE POPULATION OF THE

REPUBLIC OF MOLDOVA TO HOUSEHOLD-COMMUNAL SERVICES

Abstract

The article substantiates the expediency of using indicators related to household consumer spending when assessing the economic accessibility of housing and communal services. The central place among them is occupied by the indicator "share of expenses for payment of housing and communal services in total household consumer spending". Its analysis led to the conclusion that in 2019-2021 the economic accessibility of the population of the Republic of Moldova to housing and communal services increased, but in 2022 it significantly decreased. To compare the accessibility of housing and communal services for the population of the Republic of Moldova and foreign countries, the statistical data were brought to comparable values. It is shown that in no other EU country when paying for utilities there is such a big burden on household budgets as in the Republic of Moldova. The main reason for this situation is the establishment of high tariffs for water supply and sewerage, as well as for the use of energy resources.

Abstract The minimum wages in the member states of the European Union

in July 2020 were analyzed, expressed in euros/month and grouped into three categories according to the levels of less than 500 euros, between 500 and 1,000 euros and over 1,000 euros.
